The Record of Decision for Clear Creek Management Area Resource Management Plan Amendment and Route Designation was approved on January 13, 2006.

OFF HIGHWAY VEHICLE USE IS NOW LIMITED TO AREAS AND ROUTES MARKED WITH NUMBERED BROWN POSTS.

All unmarked routes and areas are closed to motorized use.

Compliance with the designated route/area system is critical to preserving long-term OHV recreation access

Signs are now being installed and a new map reflecting open areas and routes will be available soon.
