SUMMER USE RESTRICTIONS ARE IN EFFECT JUNE 1 THROUGH OCTOBER 15, 2006 DUE TO ASBESTOS EXPOSURE RISK

Motor vehicle travel is limited to the following routes during this period:

Clear Creek Road (R1), R2 from its west end to the T 107 junction, T153 from its west end to San Carlos Peak, R15, R16, and R11 to the Wright Mountain gate.
